The demonstration was massive and active. All our members assembled at ICF OBC association office and from their marched towards GM's office, ICF, where the program started at 11.30 a.m.

Mr.J.Parthasarathy, Working President of Federation presided the program. Mr.G.Karunanidhy, Gen.Secretary addressed the demonstration program and explained in details the demands.

Mr.K.Ramamurthy, Gen.Secretary of ICF OBC association welcomed the leaders and members from fraternal organisations and OBC members from ICF. Mr.Anbu Kumar, President of ICF OBC association and Secretary of AIOBC Federation gave the vote of thanks.

### Federation demanded the Central Government:

1. To Withdraw the order dated 6.10.2017 issued by DoPT, Ministry of Personnel, Govt. of India, New Delhi that categorises all OBC employees working in Public Sector Undertaking including Banks, Insurance and in Private Companies as coming under "creamy layer" category and hence not eligible for 27% reservation.
2. To Remove the concept of creamy layer imposed on OBCs and to bring suitable constitutional amendment on this matter.
3. To Create a separate Ministry for the welfare of OBC.
4. To Provide reservation in promotion for OBC.





Leaders and members from OBC associations of Central Govt /Public Sector Undertakings – ICF, Air India, Allahabad Bank, Balmer Lawrie, Bank of Baroda, Census, CPCL, ESIC, HVF, Avadi, IIT-Madras, MFL, NLC, New India Assurance, Salem Steel Plant, Union Bank of India, participated in the demonstration in large numbers.

Leaders of trade union in ICF also attended the demonstration program and they honoured our primary office-bearers at the event.

The arrangements have been done excellently by Office-bearers and CC members of ICF OBC association. Participants were provided snacks and Tea by them. They deserve our congratulations and appreciation.

Friends, two of our demonstrations – one at Hyderabad on 11.8.2018 and now on 11.9.2018 at Chennai – are a grand success. We have to carry this spirit and involvement of our members to the next level.

Our office-bearers meeting will be convened shortly to chalk out the next program.

Once again, we salute all our Unit Leaders and Members for their active participation and making the demonstration program a grand success.
