[BACKWARD CLASSES, MOST BACKWARD CLASSES AND MINORITIES WELFARE DEPARTMENT - ISSUANCE OF BACKWARD CLASSES COMMUNITY CERTIFICATE TO EZHUVA COMMUNITY THROUGHOUT THE STATE - CLARIFICATIONS - ISSUED.]

The following Government Order is Published.—

- 5. Report, dated 09.06.2020, of the Committee to examine the requests of Ezhuva and Thiyya Communities for Backward Classes Certificate.

Order: No. 54, Backward Classes, Most Backward Classes and Minorities Welfare (BCC), 15th July 2020.

Various representations were received for issuance of Backward Classes certificate to Ezhuva and Thiyya Communities. The views of the Tamil Nadu Backward Classes Commission were obtained on the requests of Ezhuva and Thiya Communities. In continuation, a Committee was constituted to examine the requests of Ezhuva and Thiyya Communities for issuance of Backward Classes Community Certificate in the State, vide Government Order fourth read above.

- 2. In the Government Order first read above, Ezhuva Community in Kanniyakumari District and Shencottah Taluk of Tirunelveli District (Serial No.23 of the List of Backward Classes) were notified as Backward Classes in Tamil Nadu.
- 3. In the Government Order Second read above, it has been ordered to issue community certificates to all the communities, declared or notified as Backward Class or Most Backward Class or Denotified Community in the restricted area or territory, as and when they migrate to other area or territory, declaring the same status of the respective community in the restricted area or territory by the authorities, competent to issue community certificates in the migrated area or territory.
- 4. The Committee constituted to examine the requests of Ezhuva and Thiyya Communities for issuance of Backward Classes Certificate throughout the State, has recommended in its report fifth read above, as follows:-

"The members of Ezhuva community, entered in Serial No.23 of the List of Backward Classes notified in G.O.(Ms) No.85, Backward Classes, Most Backward Classes & Minorities Welfare Department, dated 29-07-2008, may be granted Backward Classes community certificate throughout the State, as they are distributed in all the districts of the Tamil Nadu. The Committee also recommends that the orders issued in para 4 of G.O.(Ms) No.58, Social Welfare Department, dated 23-01-1976, may be followed in these cases."

5. The Government after careful consideration, accept the recommendation of the Committee and clarify that the Backward Classes Community Certificate may be issued to Ezhuva Community throughout the State of Tamil Nadu considering their presence in all the districts of the State, as recorded in the survey conducted during the year 1983, by the Tamil Nadu Second Backward Classes Commission (Ambasankar Commission). The District Collectors and the Certificate Issuing Authorities are also instructed to adhere the following orders issued in para 4 of G.O.(Ms) No.58, Social Welfare Department, dated 23.01.1976, while issuing the community certificate to the members of Ezhuva Community in the State of Tamil Nadu:-

"Only persons who belong to Tamil Nadu and to one of the communities included in the list of Backward Classes shall be treated as Backward Classes. Persons belonging to other States shall not be treated as Backward Classes in this State even though they may belong to one of the communities included in the list of Backward Classes."

6. The Commissioner of Revenue Administration is requested to issue suitable instructions to the District Collectors and the Community Certificate Issuing Authorities to follow the clarification issued in para 5 above while issuing Backward Classes community certificate to the Ezhuva Community people in the State of Tamil Nadu.

[BACKWARD CLASSES, MOST BACKWARD CLASSES AND MINORITIES WELFARE - ISSUANCE OF COMMUNITY CERTIFICATE OF THE CHILDREN BORN TO THE PARENTS BELONGING TO TWO DIFFERENT CASTES - CLARIFICATIONS - ISSUED.]

The following Government Order is Published.—

G.O.Ms. No. 477, Social Welfare Department, dated 27-06-1975

Order: No. 8, Backward Classes, Most Backward Classes and Minorities Welfare (BCC), 9th February 2021.

Vide G.O read above, Government have been extending certain concessions to the members of Scheduled Tribes, Scheduled Castes and Backward classes from time to time and orders were issued stating that children born out of inter-caste marriages, shall be considered to belong to either the community of the father or the community of the mother according to the declaration of the parents.

- 2) Various requests have now been received by the Government to issue community certificates to children born out of inter caste marriages, based on the caste of either the father or the mother.
- 3) The Government after careful examination hereby clarifies that the children born out of marriage between parents of two different castes shall be considered to belong to either the caste of the father or the caste of the mother based on the declaration of the parent/s.
- 4) Based on this declaration of the parent/s, Revenue authorities are hereby instructed to issue appropriate 'Community Certificates' (Backward Classes/Most Backward Classes/ Denotified Communities/ Other Backward Classes/ Scheduled Caste / Scheduled Tribe for Government of Tamil Nadu/ Government of India) to such children according to their eligibility, by virtue of belonging to such a caste.
- 5) The Commissioner of Revenue Administration is requested to give suitable instructions to the Community Certificate issuing Authorities as per the clarification issued in para 4 above.
